- Activities such as blood donation drive or seminar related to awareness of health related diseases could be carried out by hospital.
- Ambulance on call.
- DR. G.D. POL Foundation, YMT Ayurvedic Medical College and Hospital will provide medical services, including but not limited to general consultations, specialized care.
- They will educate and give training and workshops for the college community on relevant health topics.

DURATION:


This MoU will remain in effect from 8th July 2024 to 8th July 2025. The date of signing and may be renewed by mutual agreement.
